## World Trade Center Association, LAEDC and City of Long Beach Return to Kolkata to Explore Opportunities

*Los Angeles County is poised to strengthen existing ties with Kolkata*

**KOLKATA**—The World Trade Center Association Los Angeles-Long Beach together with the Los Angeles County Economic Development Corporation, the City of Long Beach, and the Long Beach International Trade Office brought a delegation of business and civic leaders from Southern California to Kolkata with an important objective of forging meaningful and beneficial ties between East India, and the County of Los Angeles in public and private sector industries such as logistics, health care, tourism, technology and transportation. The delegation, which visited New Delhi and Mumbai earlier this week, will be in Kolkata from March 6-9.

The delegation aims to introduce engineering, technology and transportation-related companies doing business with the Port of Long Beach and Los Angeles to local counterparts to foster long-term commercial relationships. This trade mission is being supported by the U.S. Consulate, Kolkata and the Bengal Chamber of Commerce and Industry (BCCI). The delegation will also include representatives of the City of Los Angeles International Trade office and the Los Angeles Board of Airport Commissioners.

“That expertise exists in Los Angeles County, which is home to the Port of Long Beach and neighboring Port of Los Angeles, together making up the largest port complex in the Americas and fifth largest in the world. In addition to being the primary international trade hub of the U.S., Los Angeles County is also its largest manufacturing hub. The visiting delegates will therefore seek collaborative opportunities between Kolkata and Los Angeles County in the manufacturing sector as well,” said Bill Allen, President and CEO, Los Angeles County Economic Development Corporation.

“Kolkata is part of my pledge to Mayor Shri Bikash Bhattacharya during his last visit to Long Beach to help strengthen the existing relationship between these two Sister Cities. The timing could not be better for both cities with their businesses and governments focused on expanding opportunities and improving relations,” said Long Beach City Councilmember, Dr. Suja Lowenthal.

“This is an unprecedented opportunity to promote business between Kolkata and Los Angeles County,” said Vance Baugham, President of the World Trade Center Association Los Angeles-Long Beach. “This mission is designed to harness a key portion of the extraordinary growth that is happening in India now.”
